A. Reimer: It's not within the purview of Vancouver City Council to undertake such an investigation. Have you contacted your MLA?

R. Korkut: Yes, I have! Denying the responsibility of protecting each other cannot resolve any public issue. What stopping the Mayor from making a simple call?

A. Reimer: I'm not sure what you mean by "denying the responsibility of protecting". The issue isn't a lack of responsibility: it's a lack of power to act. To that end, I will politely reiterate the question as to whether you have contacted your MLA?

R. Korkut: I will politely reiterate that "Yes, I have". "Yes, I have" means I have contacted my MLA. Obviously, you did not read my letter before responding. I will politely reiterate what I stated in my letter:

I informed Gregor Robertson that **ICBC insures and protects CRIMINALLY negligent drivers and hit and run criminals who kill 264 and injure 51,000, people a year under the LIABILITY of ICBC.** And I asked him to call **Adam Palmer**, Chief Constable and instigate the **investigation** of the **CORRUPTION** in the Supreme Court of British Columbia to **question** the Chief Justice Hinkson's authority to **DISMISS** the **LEGAL ACTIONS** of the victims of crime; *because*, it is impossible to prevent **CRIME** where criminal cases are dismissed to protect **CRIMINALS**. Certainly, I did not ask **Vancouver City Council to undertake an investigation**. It is just your imagination.

1. I was a victim of ICBC; because, ICBC denied my suffering from the potentially fatal hit and run CRIME perpetrated under its liability.
2. ICBC extorts \$4 billion dollars from the diligent drivers to insure and protect the **CRIMINALLY NEGLIGENT** drivers who kill 264 and injure 51,000 people a year.

Obviously, a Justice who dismisses the legal actions of the victims of crime to protect the criminals is more **DANGEROUS OFFENDER** than the actual **CRIMINALS**. Therefore, I was obliged to inform the PUBLIC; because, there is no other way to protect the PUBLIC, where the Courts are **CORRUPT**. Nevertheless, **Kathy Kinloch** and **Wayne Hand** terminated my employment with BCIT. Even though termination of employment of a whistleblower is **unlawful**, my union, BCGEU failed to protect me and my right to *employment insurance benefits* is denied. Since, breach of DUTY and Public TRUST is a CRIME against the PUBLIC, I reported the issue to **Adam Palmer**, VPD and **Gregory Roberson**, they *failed* to respond and *ignored* the issue.

I congratulate you for earning the TRUST of the Public and being elected as a new Mayor of the City of Vancouver. Even though, you know that your first and foremost DUTY is to ensure the SECURITY of the PUBLIC, there is no harm in my reminding it, once more. In this regard, as a member and a natural representative of the Public, I request you to call the Chief Justice **Christopher E. Hinkson** to remind him that **its unlawful to dismiss the legal actions of the victims of crime and protecting the CRIMINALS**; so that I can file a legal action against ICBC, on the grounds of *extortion* and *insuring criminally negligent drivers*. Every week, criminally negligent drivers kill 5 people and injure hundreds, under the liability of ICBC.
